Motion 1: The minutes from the January 2001 meeting were approved unanimously.

Program – Carl Lawson

Sub Committee Reports

Program -Carl Lawson

There were no programs at this meeting. There was a program slate approved at the Atlanta meeting which will be resubmitted for Atlantic City. A new commercialism policy goes into effect next meeting; no reference to software programs or anything else will be allowed. A discussion followed on which programs would be submitted for Hawaii. **Motion 2:** The Program Subcomittee report was approved unanimously.

Research - Kristin Heinemeier

The report is attached. The committee spent most of its time on priority 1, The Impact of Commissioning HVAC Systems on Life Cycle Cost. A revised version of this will be prepared. Priority 4, the Impact of Commissioning on Comfort, is a new topic that has moved up. WS1115 should be reevaluated since other groups are working on something similar.

Motion 3: The report was unanimously approved as submitted.

Handbook Chapter - Karl Stum The committee is revising the chapter for the 2003 Applications Handbook. The schedule calls for a draft September 15. This is planned to go out for review so that the chapter can be approved in Atlantic City. As much as possible will be incorporated from Guideline 1. A final draft should be sent out December 15 with a final version sent 2 weeks before the meeting. Carl Lawson commented that there are now think tank sessions. There are a lot of people upset about programs and handbooks. They feel that ASHRAE needs to get back to basics and away from special interest groups. Most say they are using the 1985 fundamentals because of errors in newer ones. Attendance is down at summer meetings. The average age of members is 53. The think tank wants to improve the society. It will meet Saturday afternoon 1-3 at the next two meetings with Richard Rooley moderating.

Long Range Planning – Gerald Kettler The LRP committee needs members. They recommend that we start thinking about a guideline for retrocommissioning. More research is needed on the results of commissioning. The report is attached.

Motion 5: The LRP report was unanimously approved.

Standards – Rodney Lewis Not present.

<u>Total Building Commissioning Guideline – Carl Lawson</u> This is moving ahead.

Web Page- Dave Shipley The website is up-to-date. Research and minutes are active.
