### MEETING MINUTES - January 20, 2008

### ASHRAE T.C. 7.9 – Commissioning New York, New York

- 1. The meeting was called to order at 3:06 p.m. by Chairman Kristin Heinemeier.
- 2. There was a motion to approve the agenda as written and it was approved.
- 3. Self introductions.
- 4. Attendance a quorum of voting members was present.
- 5. Vice Chairman J. R. Anderson Comments about the CTTC meeting will be passed on to Kristin.
- 6. Previous meeting's minutes were approved without change.
- 7. Kristin's Report.

  - e. CTTC April 16 Satellite Broadcast of Integrated Building Design Walter Grondzik will be one of the speakers. Next years focus will be on operations and the Satellite Broadcast will be about commissioning existing buildings.

- 9. Programs Rich Rose Reported Report attached.
- 10. Standards Rodney Lewis Reported 90.1 and 189P have requirements for commissioning yet there is no definition. There will be requirements included before public review per day Enck. Standard 62 Multiple Space Equation is

being required 180P is out for publication. 111 is out for publication. Guideline 0 cannot be cited in a Standard per Jerry Kettler. Kristin asked Carl Lawson to make a proposal in Salt Lake on how to monitor the definition of commissioning among all the organizations that are including it in their Standards and Guidelines.

- 11. Research David Shipley Report is on the website and on the thumb drive that is being passed around.
- 12. Handbook (Applications Chapter 42) John Castelvecchi References will be made to guidelines 0 & 1 as well as other recent ASHRAE documents concerning Commissioning. ASHRAE Certification and CX training will be addressed. Final draft January 2009 and submit for publication June 2010.
- 13. Long Range Planning Jerry Kettler Guideline 0 committee is working with other groups who want commissioning standards for their own technologies.
  - Questioning whether User Manual will be developed in house or hired out. LEED has added an extra point for building envelope commissioning in the Healthcare draft document. The development of protocols for high performance buildings may affect the commissioning industry as far as measurement is concerned.
- 14. Website David Shipley Please visit website and for officers and subcommittee chairmen, please make sure that your area is up to date.
- 15. Oversight of CX Training Walter Grondzik The purpose of the oversight subcommittee is to act as a link between TC7.9 and the development of a PDC commissioning training course. Walter has developed an outline of a course on the commissioning process and has submitted it to Joyce Abrams who is in charge of the certification effort. She will pass it on to the Professional Development Group. What happens after that, Walter is unsure.

#### COGNIGENT COMMITTEE LIAISON REPORTS

- 16. Commissioning Certification Jerry Kettler There will be 10 members and 5 corresponding members. Not all of the 15 are from ASHRAE. They will create a body of knowledge of what is to be known by someone who is certified. This will be a management certification not of a specific piece of equipment. It will be open to people outside of ASHRAE. The purpose of the certification has to do with the process not particularly HVAC.
- 17. Guideline 0 Jeff Traylor Several modifications have been passed and will go out for public review.
- 18. Guideline 1 Walter Grondzik Guideline 1 is on hold concerning a trade mark terminology that is included in the guideline. The guideline is ready to print but

- the Board of Directors of ASHRAE will vote on the trademark issue before printing can take place.
- 19. GPC 1.2 Rick Casault Committee has existed for a year now and has good progress on a draft. The current title, purpose and scope of the committee is to describe the process for commissioning existing HVAC & R Systems. The committee has voted to separate the process from the technical requirements. Rick met with people from Standards and will be submitting a proposal for a revision of the title purpose and scope. Options include Guideline 0 as the definition of the commissioning process. This would be supported by several guidelines for the technical requirements. Guideline 1 and Guideline 3 are examples. N1BS encouraged ASHRAE to develop technical requirements for all the various systems in a building. An ASHRAE committee would draw together experts from AIA, plumbing etc. to contribute to the development of technical requirements in an ASHRAE publication or a series of publications.
- 20. GPC 31P O & M training for HVAC & R CX Walter Grondzik Will meet on Tuesday from 1:00 to 2:30. It is now GPC 1.3.
