5. Subcommittee Reports:

- a. Handbook Liaison, David Fisher:
 - i. David Fisher mentioned: The cycle has been finished-up for the refrigeration handbook. For the upcoming year we need to form a subcommittee and assign chapters for review.
 For the upcoming year TC 10.8 needs to see the online form for chapter reviews and each chapter should have its own review form submitted. Those forms should be submitted to, both, Heather Kennedy & David Fisher. Changes submitted will go into the online version immediately.
 - ii. Don Fenton mentioned: Someone needs to take over the Handbook committee chair. TC needs to think about what items/issues may need to be added in the next iteration. This year the TC needs to determine which enhancements to make for submission next year. TC 10.8 members should each try to discover/suggest material that should be added to the handbook.

b. Research – Liaison, Dr. Ezzat Khalifa:

- i. Dr. Ezzat Khalifa sees no RTARs in action.
- ii. Doug Scott is working on one, but needs to discuss via conference call with the TC. He will setup a webmeeting to discuss 1434 (review text and finalize). He will also setup a web-meeting to discuss phasechange material (PCM) topics for future programs. Doug recommended breaking the topic into categories such as "active" vs "passive" PCM applications.
- iii. Ongoing discussion that needs to be concluded is defrost load efficiency of various systems, which is a high priority item to be added to the agenda at the next meeting. The topics are still: defrost loads, insulation, infiltration (i.e. dock doors).

c. Programs – Dan Dettmers

- i. Don Cleland recommends that a refrigeration committee ad hoc group meet with section chairs to discuss the dimming spotlight on refrigeration. The TCs should clearly convey "what the issues are".
- ii. Group discussion included how to remove any TC 10 "clashes" (overlapping meetings). It was noted that 10.1 should consider moving to a non-conflicting time, vs 10.7.
- iii. There is a need for panel discussion regarding "research on the challenges and unknows of estimating refrigeration loads". Action item given to Tobey Fowler.

i. Don Fenton noted refrigeration facilities appear to be exempt from 62.1
