- iii) Several other cases of detection have been reported. Definite increase in positive testing cases now that many facilities are routinely testing.

- v) Dr. Stout indicated that the CDC is reporting an approximate increase in reported cases of 300%.
- vi) Discussion of outbreaks in press is becoming a politically charged issue in some cases, specifically recent VA activity.
- vii) Cost associated with known cases is estimated at \$300 Million.
- b) Probiotic Treatment
 - i) Travis English provided an update. Kaiser Permanente has performed a pilot but the results have not been provided. Preliminary information suggests results are not favorable.
 - ii) Dr. Stout provided discussion regarding testing of samples related to alternative treatments and the need to ensure that testing labs are properly equipped to test for Legionella.
