Call to Order & Establishment of Quorum

Meeting was called to order by Vice-Chair Thaddeus Rogowski at 4:15 p.m., January 14th 2018. Quorum was **not** established with **8 of 18 voting** members in attendance.

Membership/ Roster

Briefly reviewed roster updates. Steven Trent (Boeing) was discussed to take on the TC 9.3 Secretary position from Jerome Johnston (Boeing) who will be becoming a non-voting member.

Old Business

Approval of Houston 2018 meeting minutes discussed. In general agreement to approve the Houston 2018 minutes but did not have quorum.

Approval of RP 1262-2 is contingent on Battelle releasing project data to ASHRAE.

New Business

RAC wants to drive RP 1262-2 to closure. Battelle needs to submit final presentation by March 18th, 2019 to support the winter meeting in Orlando. Robert Cordo is the new principle investigator (PI) for Battelle.

RP 1830 went out for re-bid. Evaluated during the research subcommittee meeting. An executive meeting is required (voting members minus conflicts) to hold a vote. Executive meeting to be scheduled online due to lack of quorum.

Other committee support for Cognitair project. \$180k has been approved to support this effort. Received a memorandum of understanding from Fraunhofer, who will get their first payment soon.

Mass transit committee working on an RTAR for Fresh Air Volume.

Research Committee Report

- Battelle presented at the Houston meeting but still needs to formally submit the presentation to ASRAE and present.
- RP 1830 going out for re-bid. Re-bid with changes to the RP, including American Airlines as a possible partner and location for testing ultrafine particles. An executive meeting is required (voting members minus conflicts) to hold a vote.
- Cognitair project was discussed. A focus is cognitive function using CO₂, Altitude and Humidity as variables.
- Mass Transit RTAR to investigate taking credit for open doors as providing fresh air ventilation.
- FACTS, Clean Sky 2 research projects were discussed

Handbook Sub-Committee

ASHRAE Handbook 2019 was published.

Automobile Subcommittee Report and Issues requiring Committee Action
