 - i. By Phoenix meeting we need to determine what we want to update
 - ii. Provide any feedback to GD
 - 2. Systems and Equipment - Chapter 41 - 4/11/2027 for next revisions
- b. Programs (**Slayzak**)
 - i. AHRI branch in MENA reached out and started a working group to establish certification standards for evaporative cooling
 - 1. Steve suggests having a forum on the AHRI working group
 - They create the rules but reference ASHRAE for standards
 - Steve is happy to lead that forum
 - i. Could expand it to a panel if needed
 - ii. Due on February 26th
 - 2. Too late for any seminars for Phoenix
 - We should propose something for Las Vegas or Austin
 - i. We need a topic for Las Vegas
 - 1. Water efficiency related - Steve to reach out separately
 - a. Condair/Munters/Seeley
 - 2. Practical example?

- c. Research (**Mittal**)
 - i. TC5.11 is looking at moisture in buildings (optimal RH to maintain) from a health aspect (instead of comfort)
 - 1. Looking for support
 - 8.10 (dehumidifiers) is supporting
 - No official request
 - i. 5.11 research chair will reach out to 5.7 for review and request for support
- d. Website (**Miller**)
 - i. Needs a few docs from 24/25 but otherwise up to date
- e. Standards (**Graef**)
 - i. Standard 212
 - 1. Mark Modera has taken over leadership of that and putting together a committee
 - If you'd like to support go to the standards page on ASHRAE website (need a balanced committee)
 - This will be the main focus for standards
 - ii. Standard 133/143 are available in the bookstore now
 - Cleaned up and references to 41 series of standards

11. Old Business

- a. How can TC5.7 help to address the growing concerns over water usage in evaporative cooling solutions?
 - i. Gas turbine pre-cooling has some calculations (basically rules of thumb) for cooling towers and evaporative coolers for design conditions and water consumption
 - 1. Pat provided a spreadsheet for calculations
 - Calculates based on 1 hour of time
 - Annette to find the chapter and also check the online version to see if the calculator is available
 - Could be added to our hand book if it's been removed (or could be archived if we request to ASHRAE)

12. New Business

- a. DOE Energy plus doesn't include evaporative cooling (does include Celdek)
 - i. It's basic (you have to build the system)
 - ii. Might be worth looking at a research project to help get evaporative cooling integrated
 - 1. Nick could take lead on this
- b. Website shows this meeting as 5-7PM (actual meeting time is 4-7PM)
 - i. What would be the meeting time for Phoenix
 - 1. Cheng-Min would prefer 5-7 for conflict with another TC
 - ii. Check that the roster is updated
