Handbook - Handbook Sub-Committee Chair, Ralph Kittler

- 1. For the Handbook we are in very good shape. If anyone has any suggestions for improvements, they are welcome to forward to Ralph.
- 2. There is a new chapter in 2020 ASHRAE Handbook—HVAC Systems and Equipment to include DOAS-specific design considerations. It highlights common issues or challenges engineers can face when incorporating the systems into an overall HVAC design.
- 3. For the dehumidifiers chapter, we might want to mention something green about refrigerants and the new low GWP options like R32. Maybe also mention some technologies (refrigerant pressure transducers) that help reduce the number of manifold gauge connections needed. Thoughts?

Research - Research Sub-Committee Chair, Alois Malik

- 1. New Updated RTAR 1566 "Equations to Estimate Evaporation Rates from Wetted Surfaces"
 - a. 1566-TRP-C has not yet been released for Bid as planned for spring 2020. Due to the Covid-19 issue, there has been a shortfall in funding for ASHRAE research. Since money must be secured prior to release, there are delays in getting some projects out to bid. RP-1566 is the oldest RP in the queue (which is an advantage) but is not the lowest cost. Prioritization of which RPs to push out in the Fall will be made when the funding has been confirmed, which is hoped to be sometime in July.
- 2. Co-sponsor RTAR-1901 with TC2.2
 - a. D. Dettmers (primary author for RTAR-1901) provided update
 - 1) Conditionally approved
 - 2) Working on conditions for approval

Standards - Standards Sub-Committee Chair, Craig Burg

- 1. ASHRAE Standard 190-2013, Method of Test for Rating Indoor Pool Dehumidifiers
 - Released for public review and begins in July and ends in November
- 2. ASHRAE Standard 198-2013, Method of Test for Rating DX-Dedicated Outdoor Air Systems for Moisture Removal Capacity and Moisture Removal Efficiency
