TC 1.12 Moisture Management in Buildings

1 to 3pm, January 23rd 2010 Rosen Shingle Creek Resort, Wekiwa 3 (2), Orlando, FL

1. Call to order: Ray Patenaude - Chair

Chair Patenaude called the meeting to order at 13:03.

Introductions, signup sheets passed around, roll call and check for quorum. Quorum established; 10 members present; 4 absent.

2. Self introduction of members and guests – Lew Harriman

Introductions. No Liaisons present.

3. Approval of minutes from Louisville meeting – Steve Cornick

Motion: Jeff Traylor moved to accept the draft minutes from Louisville as is; Holly Bailey seconded. Motion carried (9,0,0,CNV).

4. Review and adjust agenda

Changes to the agenda; Chair Patenuade suggested that the meeting adjourn 10 minutes early, 14:50. Agenda approved (original Agenda attached).

5. Chairman's report – Ray Patenaude

Chair Patenaude would like the members to promote the committee; and moisture measurement in buildings. He suggested a communications portal for members and corresponding members to use between the meetings since most of the meeting is taken up with the business of the TC. Chair Patenaude also suggested that if the TC members approve, the committee would continue to make short (20 minute) presentations at the TC Annual and Winter meetings. He asked for any comments following this meetings presentation by Lew Harriman.

Action item: Chair Patenaude and Steve Cornick will investigate and endeavor to setup a communications portal for the committee (Google groups for example).

6. Research – Lew Harriman (Subcommittee report attached)

Lew Harriman gave a brief background to WS-1566 "Equations to Estimate Evaporation Rates from Wetted Surfaces in Natatoriums and Commercial/Industrial Buildings." This is considered the final version of the work statement. PES person from TC 1.12 is either Harriman or John Murphy.

Action item: Harriman will take the following comments to TC 8.10 and the WS authors:

- There is concern re: the lack of consulting engineers on the PES/PMS.
- It was suggested a heat and mass transfer person be on the PES/PMS carried.

Motion: The Committee supports WS-1566 as written. Moved by Harriman; Seconded by Paul Schipp; Vote (10,0,0,0)

Other topics

- DOAS design guide waiting to go out to bid in the spring. PMS/PES will have either Harriman or Murphy as TC 1.12 representative for 1565-TRP.
- Alex McGowan went through the four ASHRAE Handbooks searching for moisture related items; he will circulate the list to the committee.
- Larry Elkin's moisture management in Net Zero buildings/houses was deemed to be not ready for submission to RAC.

8. Publication and Communications

- a. Website Regarding the TC web site it to be seems to be OK.
- b. Handbook Holly Bailey lead a discussion as to whether TC 1.12 should be the cognizant committee for a new chapter or existing chapters or special publications. McGowan conducted a search of the four ASHRAE handbooks for moisture related issues. He will circulate the results to the TC. Participants were encouraged to contact Holly Bailey, if they are interested, to be put on the discussion list regarding a Handbook chapter for TC 1.12. It was suggested that entire committee, voting and non-voting be cognizant of this. Chair suggested that this might be a good use communications tool for working documents (e.g. Google groups).

9. Old Business

- a. ASHRAE's Mould position documents. Rodney Lewis gave a brief history of the current documents; a committee was established to re-up the document, every 2years. The new document has passed 7 to 1. The primary problem is the references and the secondary problem is the tone. Lewis recommended that the committee vote against it until it has been cleaned up. The impact in Lewis' opinion is that the document is adverse and will have negative impact on members. The document has left the project committee stage and has been submitted to Tech Council if we are the cognizant committee, we need to be aware.
- b. Humidity control standard Harriman reported that there was nothing to report.

Action item: Chair will track the mould position document and report back to the committee. **Action item:** Lewis will give a mini-presentation to the committee on the mould position document in Albuquerque.

9. New Business

- a. Mini-presentation Harriman gave a short presentation of mould problem in health facilities in Malaysia.
- b. EPA Moisture control guidelines EPA began trying to develop guidelines for moisture management in buildings about 4 years ago. Harriman was involved as editor on HVAC side. Don Gatley, plus many other ASHRAE people, has been involved. The document is almost ready for publication; it has been ready since Feb. 2008. It needs to be edited; there was a suggestion that ASHRAE could print it as joint publication as a possibility.
- c. A brief discussion was held on alternative meeting dates. Due to many conflicts consensus was to retain status quo.

Action item: Chair Patenaude will propose a forum on the EPA guidelines; Patenaude moderator.

1. Status of 1565-TRP: Development of the ASHRAE Design Guide for Dedicated Outdoor-Air Systems

Sponsoring TC: 8.10 (Mechanical Dehumidification Equipment and Heat Pipes) **Co-sponsoring TCs:** 1.12 (Managing Moisture in Buildings), 5.5 (Air-to-Air Energy Recovery), 8.12 (Desiccant Dehumidification Equipment and Components)

- In October 2009, the work statement was approved by the ASHRAE Research Administration Committee (RAC).
