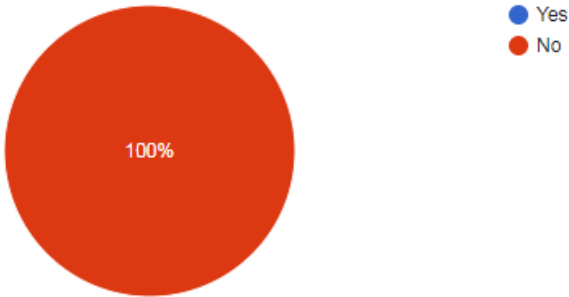

Research Budget

- Typically \$2.6M - \$2.7M per year
 - Donations
 - Research Promotion sponsored events
 - AHR Expo contribution
- Funds collected in a given SY becomes RAC budget in next SY
- Funds:
 - Research Projects – 12-15 new projects per year
 - Grants and Awards
 - Innovative Research Grants (\$125k over 3 years)
 - New Investigator Award (\$125k over 3 years)
 - Grant In Aid – Typically 20-25 per year @ \$11,500

Fiscal Impact from Covid-19

- Reduced revenue from closures, cancellations, austerity
- Top Priority: Ensure continuity of core function
 - TC developed research addresses members most direct needs
- Unsolicited Research Projects (URPs) will not be considered for now
- Grants and awards will be delayed until budget is approved, may be suspended
